# Sunnyhills Tennis Club Membership Terms & Conditions May 2022

### **Membership**

- The details set out in my application for membership form are true and correct. If they
  change, I acknowledge that I am required to notify my club manager of changes in writing as
  soon as possible after they occur
- I will be bound by the Constitution, Regulations, Policies, Guidelines and reasonable direction of my club, Auckland Tennis of which my club is a member and Tennis New Zealand
- I have voluntarily accepted and assumed the inherent risk of danger and injury in tennis. Sunnyhills Tennis Club endeavours to create a safe sporting environment. All members and their visitors are expected to behave appropriately for the safety of themselves
- The club encourages members to volunteer their time to help at the club at events such as the Working Bee, Junior Club activities, fundraising and Open Day etc.
- It is not the policy of the Club to provide refunds on memberships in the event you change your mind, however we will consider requests in the event of injury or unforeseen circumstances and will endeavour to reach an amicable solution

### **Court Usage**

- Co-operation and consideration are expected at all times
- Scheduled club play, interclub and organised coaching have priority over casual play
- Ensure the gates are fully closed when you leave
- Court keys can be issued for a fee of \$15 and are only given to eligible members 16 years or older

### **Court Behaviour**

 Language and behaviour on the court that is unbecoming to the game of tennis will be viewed seriously by the Management Committee. Members and guests are expected to act responsibly at all times when using club facilities

### **Court Attire**

- When playing on the club courts, appropriate tennis clothing must be worn at all times.
- Only approved footwear suitable for artificial grass surfaces shall be allowed.
- Players incorrectly dressed may be asked to stop playing

### **Visitors**

- Visitors may join organised club play upon the payment of a visitor's fee of \$5 per player
- At all other times, non-members can use the courts only when accompanied by a member and where court fees of \$5 per persons per hour must be paid in the box provided at the entrance of the club, prior to play. Casual players may only visit up to 3 occasions during a season, after which full membership must be paid for full use of the courts
- The member is responsible for the behaviour or any guests they bring to the club

### Clubhouse

- Club members are required to maintain the cleanliness of the clubhouse by tidying up before leaving.
- Children are not to be left unsupervised in the clubhouse at any time

 It is the responsibility of those last to leave to check that all doors and windows are securely locked, lights are off, dishes are washed and put away, toilets clean, furniture in place and the floor swept

## **Problems/Issues**

 Members are required to report all breakages or issues to the Head Coach, President or Club Manager immediately

### **COVID Vaccination Policy**

• There is no requirement for a member to provide proof of vaccination to access both the outdoor areas (courts, deck and surrounds) and/or the indoor areas (clubhouse and toilets)

### **Privacy**

I agree that the Club, Tennis Auckland and Tennis New Zealand can collect, hold, use my personal information on the application for membership form (and any updated or additional personal information the Club, Tennis Auckland or Tennis New Zealand obtains from me including any photo or other record of my image for the purposes of:

- a) Processing my application for membership including notifying Tennis NZ of the information on the application for membership form for the purposes of the club, the Regional Centre and Tennis NZ compiling a register of members in accordance with the Incorporated Societies Act 1908 and for the purpose of compiling a national database of members and participants (accessible only by my club, the Regional Centre and Tennis NZ);
- b) If I agree putting my name and contact information on my club's membership list for other members of my club;
- c) Publishing any of my tennis results in my club, the Regional Centres and/or Tennis NZ newsletters and on their websites;
- d) Selecting and naming publicly players, officials and teams to represent the club, the Regional Centre and Tennis NZ at tennis events;
- e) If I agree providing me with information and activities relating to my club, the Regional Centre and Tennis NZ or other tennis matters;
- f) If I agree enabling sponsors and funders of my club, the Regional Centre and Tennis NZ to contact me with information about their product;
- g) Enabling my club, the Regional Centre and Tennis NZ to comply with any statute, regulation, bylaw or other regularity instrument that requires collection or disclosure of my personal information; and
- h) Any other purpose I agree to in writing INNYHILLS
